## <u>Subject: Change in methodology and revision in price of Biogas/CBG under CBG-CGD Synchronisation scheme</u>

Dear Sir,

- 1. This has reference to MoP&NG Policy Guidelines dated 09.04.2021 and MoP&NG letter dated 26.10.2021 regarding operationalization of guidelines for supply of Biogas/CBG under the CBG-CGD synchronization scheme.
- 2. A committee was earlier constituted by MoP&NG comprising of PPAC, GAIL, IOCL, IFGE, IBA to review the Biogas procurement price. Thereafter, during various review meetings convened by MoP&NG wherein representatives from the abovesaid stakeholders participated, the following changes to Biogas pricing methodology under CBG-CGD Synchronisation Scheme were discussed and decided for implementation: .
  - a. Biogas procurement price payable to Biogas producers would be computed on the basis of 85% (as against 80% at present) of average of CNG price slabs (placed at **Annexure-I**), corresponding to average CNG RSP of GAIL associate CGD companies (i.e. GAIL CGDs, GAIL's joint ventures and subsidiary i.e. GAIL Gas) across the country.
  - b. For cascade transportation, a transportation charge (in Rs/kg) from Biogas plant upto delivery point would be paid to Biogas producers by the beneficiary CGD entity, which is tabulated below:

One-way distance from Biogas plant upto delivery point	Transportation Charges
0 – 50 km	NIL as transportation charges upto 50km is included in the Biogas procurement price
>50 – 75 km Rs. 1.5/kg	
>75 km	Rs. 2.5/kg

- c. In line with the revised methodology, the revised price of Biogas under Synchro scheme works out to Rs.1478/MMBTU, excluding GST, which would be effective from 01.06.2025 till 31.10.2025.
- 3. No revision is proposed in the other terms and conditions governing the price of Biogas/CBG under the Synchro scheme, including the floor price which would remain unchanged at Rs. 770/MMBTU.
